Avoid contact with the eyes and skin.

*Respiratory protection:

In case of brief exposure or low pollution use respiratory filter device. In case of intensive or longer exposure use self-contained respiratory protective device.

Where risk assessment shows air-purifying respirators are appropriate use a respirator with multi-purpose combination (US) or type ABEK (EN14387) respirator cartridges as back up to engineering controls. Protective gloves
